For the March edition, we will concentrate on the following items:

- A. Approved Employee List
- B. Texting Notification

Both applications are designed to promote efficiency and better utilization of the software.

The approved employee list insures that when an employee fails to clock in to an assigned building and the supervisor receives a notification of a no show, the supervisor can look at a pre-approved list of employees who match the specific needs for that building. This list of approved employees can be customized to fit the needs of certification, training, experience or whatever the requirements are. When the supervisor needs to quickly fill a spot the pre-approved list is available for reference and only those employees who match the criteria are displayed. He or she doesn't need to search a vast data base to look for a qualified employee thus saving time and frustration, making the application more efficient.

The Texting Notification addition allows the company to stay in communications with your employees and supervisors. The texting process can be accessed from two specified points in your ExpressTime Data Manager.

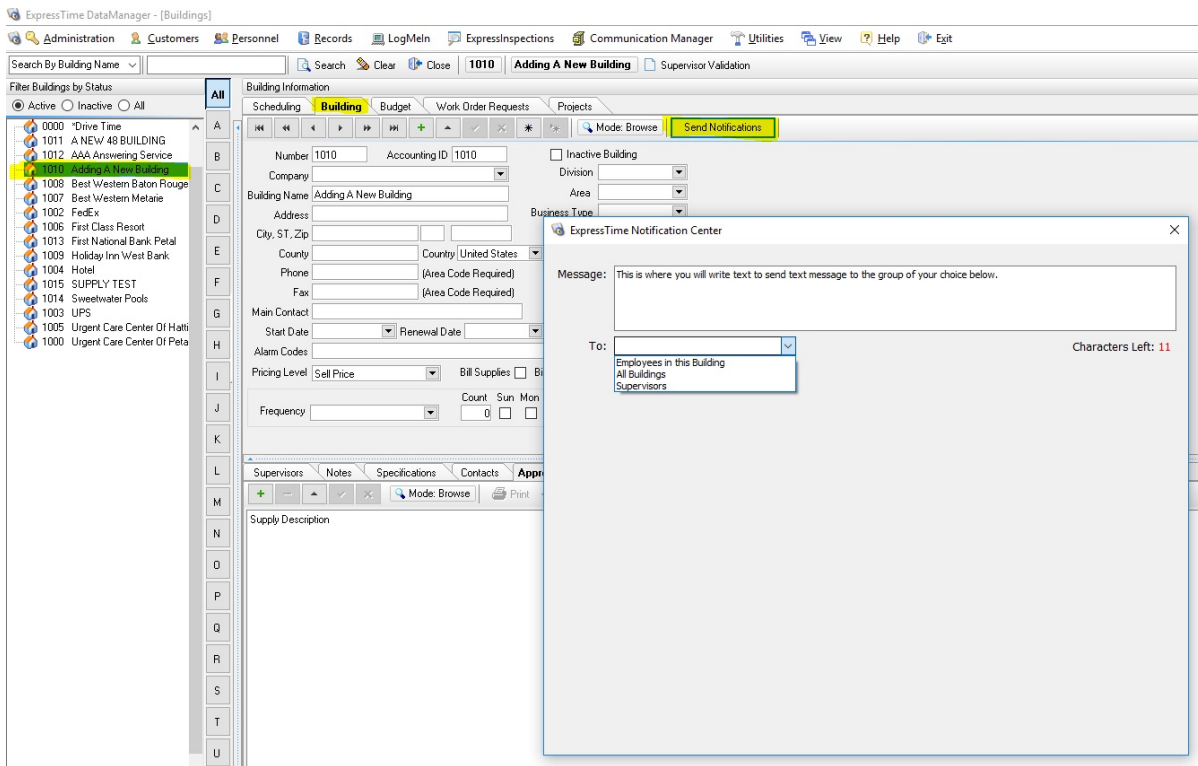
You can text your employees and supervisors from the employee record by clicking on the “send notification” tab.

You can also text your employees and supervisors from the building record by accessing the send notification.

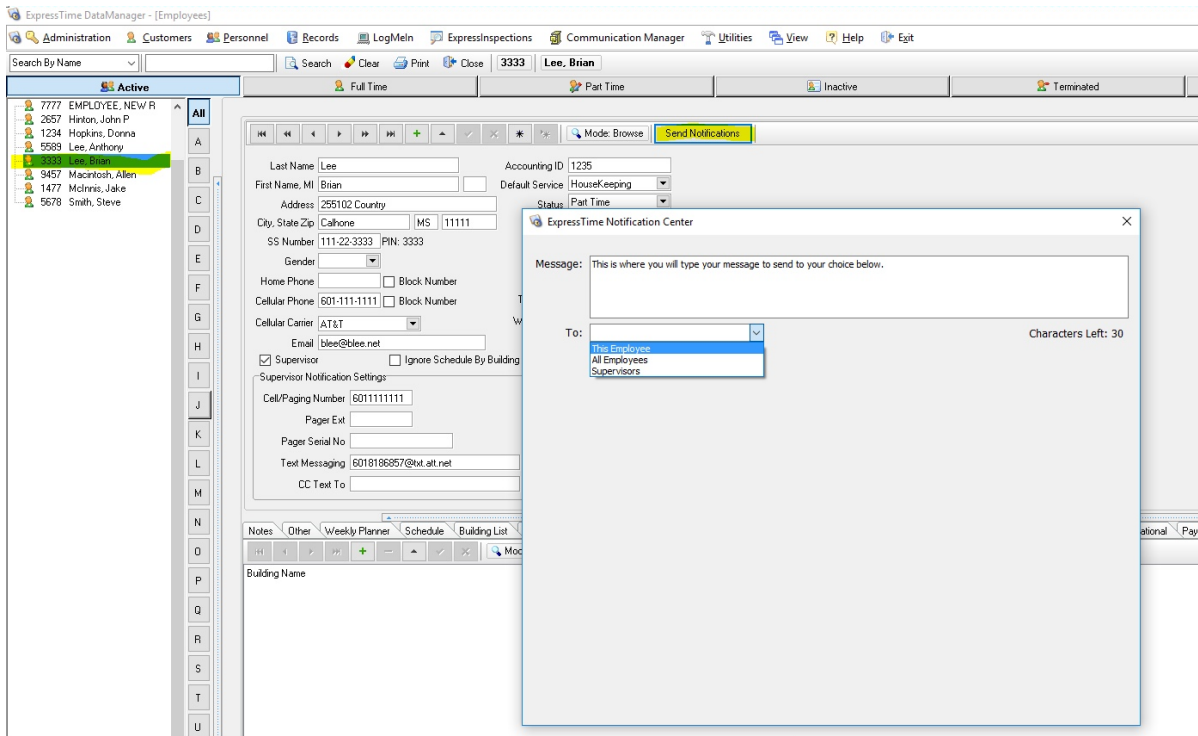
You can choose to send the texting to a specific employee, a group of employees or all employees. You can do all the same for supervisors.
